Terms of Agreement with The Hills

Presented by: BILL MINICK

1. Governance:

Mutually-agreed shepherding plan to immediately include *at least 2 current Skillman members* and 2 current Hills members who are future-focused and mission-minded.

2. Worship Experience:

Continuation and improvement of a cappella service in the Chapel on Sunday mornings.

3. Missions, Foreign and Domestic:

- **Continued care for the elderly**, including programs, events, transportation, visitations, etc.
- Continued Restriction and Dedication of Moeller and Johnson funds to fully honor their purposes for elder care, missions and youth.
- Funding of all current foreign and domestic missions
- Seats on The Hills Missions Committee and Council
- Invitation into opportunities for substantially increased funding in all areas above.

4. Finances:

All known and unknown liabilities and expenses transferred and indemnified

5. Facilities:

Transferred with a restriction on sale

for at least 5 years.

6. Staffing and Human Resources:

- Expanded, full-time ministry and administrative staffing
- Continued employment or 9-months severance for current staff
- Onsite janitorial and security
- 24/7 maintenance support

7. Child Development Center:

Full support of CDC mission, budget, operations, and staff.

8. Celebration of Skillman's Heritage:

In the many ways described above, along with a **special event, commemoration and dedication** developed with Skillman members.

Second Consecutive Year for Operating Loss

	Actual	Budget	Deficit
Total Member Contributions	685,274	\$712,400	(\$27,126)
Total Revenues	\$1,079,386	\$1,110,285	(\$30,899)
Total Expenses	\$1,095,360	\$1,110,285	(\$14,925)
Net Income (Loss)	(\$15,974)		

While these losses have been relatively small, they are an indicator of a trend.

Member contributions have shrunk 32% over the past six years:

Year	Member Contribution	Year Over Year Pct Chg
2016	\$1,001,525.16	-
2017	\$950,441.50	(5.10%)
2018	\$920,456.36	(3.15%)
2019	\$749,985.89	(18.52%)
2020	\$717,339.19	(4.35%)
2021	\$685,274.26	(4.46%)

This trend has accelerated in 2022.

Projected Results for 2022

First Quarter 2022 Member Contributions (January to March):

Actual	Budget	Deficit
\$89,001	\$178,100	50%


Projected Operating Loss for First Quarter 2022 = \$99,078

Projected Operating Loss for Calendar Year 2022 = \$400,000 (half of 2021 year-end unrestricted cash & investments)


The Outlook of Do-Nothing

Skillman's Membership




Age

Older Members




Average family net worth, defined as the value of all assets like cash, stock and homes

Assuming No Change in the Historic Pattern

From a business perspective, Skillman is not viable.

- Insolvency will result within 2 to 5 years.
- Adequate funding of expenses and building maintenance requires \$800,000 per year.
- As younger members will contribute less, Skillman's membership must be approximately 350 to remain viable.
